15-DAY PUBLIC NOTICE AND COMMENT PERIOD NOTICE OF PUBLIC AVAILABILITY OF POST-HEARING CHANGES AND AVAILABILITY OF DOCUMENTS ADDED TO THE RULEMAKING FILE

TOXICITY CRITERIA FOR HUMAN HEALTH RISK ASSESSMENTS, SCREENING LEVELS, AND REMEDIATION GOALS

Pursuant to Government Code section 11346.8, subdivision (c), and section 44 of Title 1 of the California Code of Regulations, notice is hereby given that the Department of Toxic Substances Control (DTSC) has revised the text of the proposed regulations to adopt California Code of Regulations (CCR), Title 22, Division 4.5, sections 68400.5, 69020, 69021, and 69022 to set a narrative cleanup performance standard, and adopt the listed toxicity criteria for all human health risk assessments calculating human health risk-based screening levels and remediation goals at hazardous substance release cleanup sites in California. A written comment period has been established and is scheduled to commence on April 6, 2018 and conclude at 11:59 PM PDT on April 21, 2018.

The proposed regulations will adopt specified California toxicity criteria for use in human health risk assessments to set human health risk-based screening levels and remediation goals for both corrective action under the Hazardous Waste Control Law (Chapter 6.5) and response actions under the Hazardous Substances Account Act (Chapter 6.8). Note also that because execution of the California Land Reuse and Revitalization Act (Chapter 6.82) specifically refers to Chapter 6.8 for risk assessments, screening levels, and remediation goals. Chapter 6.82 will also be governed by this rule.

The purpose of this notice is to provide interested parties with the opportunity to review and comment on 1) proposed changes to the originally-proposed text of these regulations and 2) additional documents that DTSC is adding to the rulemaking file. DTSC mailed the original text and made it available for public review and comment on *August 4, 2017*. A public hearing was held on *September 20, 2017*, during which written and oral testimony was accepted. In addition, written comments were accepted during a 45-day public comment period, which ended on *September 20, 2017*. As noted

above, DTSC has made post-hearing changes to the proposed text. DTSC considers these changes to be “sufficiently related,” as defined in the California Code of Regulations, Title 1, section 42. DTSC has also determined that these changes would have less than significant effect on the environment, including impacts from green house gases as previously described in the Notice of Exemption prepared by DTSC pursuant to the California Environmental Quality Act (CEQA).

A copy of the revised text is attached. Single underline represents original proposed text. The ~~double strikethrough~~ represents text deleted from the originally proposed text and the double underline text represents additions to the originally proposed text.
