FILTER RECYCLING SERVICES, INC., RIALTO, SAN BERNARDINO COUNTY,

Dear Mr. Bennett:

The Department of Toxic Substances Control (DTSC) has completed review of the petition for review (appeal) of the final permit modification decision issued on April 21, 2014, for the Filter Recycling Services, Inc. (FRS) facility located at 180 West Monte Avenue in Rialto, California. Please find the enclosed Final Appeals Decision and Order, Docket PAT-FY14/15-001, (Final Order) pertaining to the appeal.

On August 25, 2014, DTSC's Permit Appeals Officer granted review of five (5) appeal comments. The Final Order contains analyses and determinations concerning the five appeal comments granted review. The Final Order constitutes DTSC's final permit decision pursuant to California Code of Regulations, title 22, section 66271.18. DTSC partially grants appeal comment 4 and denies appeal comments 1, 2, 3, and 5. The permit is hereby remanded to the DTSC Office of Permitting to incorporate the pertinent revisions in the permit as specified in the Final Order. The stay of the permit issued by DTSC on June 6, 2014, is hereby vacated. The FRS permit of April 21, 2014, as revised in accordance with the Final Order, becomes effective as of the date of this letter.
