**PUBLIC COMMENT PERIOD: February 2, 2011 – March 3, 2011**

The Department of Toxic Substances Control (DTSC) invites your comments on the Draft Removal Action Workplan (RAW) or draft soil cleanup plan for the property at Tower Court, 815 West Capitol Avenue, West Sacramento, California 95691.

The draft RAW outlines plans to dig up and truck off about 1,500 cubic yards of soil having lead at amounts exceeding levels that are protective of human health for unrestricted land use.

As required under the California Environmental Quality Act (CEQA), DTSC's analysis concludes that the proposed cleanup will not have a significant negative effect on the environment. As a result, DTSC has prepared a Notice of Exemption under CEQA.

If approved, the City of West Sacramento plans to begin digging in May 2011, taking two weeks to complete the work.

**The public comment period begins February 2, 2011 and ends March 3, 2011.** Comments must be postmarked or received by **March 3, 2011.** You may send all comments in writing to:
