SOIL REMOVAL WORK FOR 1601 MARIPOSA SITE

SAN FRANCISCO, CALIFORNIA

WORK BEGINS WEEK OF FEBRUARY 12, 2018

WHAT ARE THE APPROVED PLANS FOR THIS WORK?

- Response Plan (approved by DTSC, June 2016).
- Phase II Remedial Design and Implementation Plan (approved by DTSC, February 2017).

WHAT IS THE WORK?

- Workers will dig trenches for building footings and will generate approximately 3,000 cubic yards of lead contaminated soil. Trucks will transport soil to permitted disposal facilities.

WHEN WILL YOU SEE WORK?

- Expected dates: February 12, 2018 through April 30, 2018.
- Monday – Friday, 7:00 a.m. to 4:30 p.m.

WHERE WILL YOU SEE WORK?

- Approximately 100-120 trucks will enter and exit the site on 18th Street.
- Digging will occur on the east side of the site near Carolina Street.

WHAT SAFETY MEASURES WILL BE IN PLACE?

- Controlling dust by spraying water or spray-on coating on exposed soil.
- Cleaning truck cab, trailer, and wheels of soil or mud before leaving the site.
- Covering loads before the trucks leave the site.
- Following specific transportation routes.
- Stopping excavation due to wind as follows: 1) over 15 miles per hour for 15 minutes, or 2) gusts over 25 miles per hour.

HOW WILL THE WORK IMPACT YOU?

- All streets will be open as usual.
- Loaded trucks will leave the site on 18th Street, travel north on Carolina Street to 16th Street and then east to Interstate 280. See figure.

WHO WILL DO THE WORK?

- Contractors for the property owner with DTSC oversight.
