WHAT IS BEING PROPOSED - The California Department of Toxic Substances Control (DTSC) invites the public to comment on the draft Response Plan to clean up contaminated groundwater at the Pacific Palisades Village Gasoline Station located at the intersection of Sunset Boulevard and Swarthmore Avenue in the Pacific Palisades neighborhood of Los Angeles (Site). The Site is located adjacent to an existing retail area commonly known as Pacific Palisades Village. The draft Response Plan describes summarizes environmental investigations that have been conducted and the proposed cleanup activities.

CALIFORNIA ENVIRONMENTAL QUALITY ACT – Mitigated Negative Declaration (MND)– The proposed project activities were evaluated in the Initial Study and MND that were prepared by the City of Los Angeles as part of the Pacific Palisades Village Redevelopment Project. The Initial Study and MND concluded that the proposed cleanup activities will not have a significant negative effect on the environment. The 30-day public comment period on the draft Response Plan runs from April 4 through May 6, 2016.
