WHY YOU ARE BEING NOTIFIED: The California Environmental Protection Agency, Department of Toxic Substances Control (DTSC) invites public comment on the Draft Removal Action Workplan (RAW) for the former Pomona Manufactured Gas Plant (MGP) Site to remove contaminants in the shallow soil at the Former Pomona Manufactured Gas Plant Site located in Pomona. The draft RAW is available for a 30-day public comment period between October 27, 2017 and November 27, 2017. The objective of the RAW is to remove soils with chemicals of concern (COCs) that exceed unrestricted residential use levels, which will be protective of future intrusive workers and future site occupants. The COCs are Polycyclic Aromatic Hydrocarbons (PAHs), metals, Total Petroleum Hydrocarbons (TPH) and Volatile Organic Compounds (VOCs). The Site is currently used by the City of Pomona as a maintenance yard and will continue to be used as such after remediation has been completed.

In compliance with the California Environmental Quality Act (CEQA), the City of Pomona has prepared a draft Initial Study (IS) for this project. The draft IS concluded that the work proposed in the RAW will have no significant adverse impacts and resulted in the preparation of a Mitigated Negative Declaration (MND).
