Proposed Remedial Action Plan For Victoria Golf Course (former BKK Carson Landfill) Site Available For Public Review & Comment

Our agency, the Department of Toxic Substances Control (DTSC), invites the public to review and comment on a proposed plan to enhance the containment of contaminated soils and waste debris, and maintain a soil cover and monitor landfill gas, at the Victoria Golf Course Site (known as the former BKK Carson Landfill). The proposed plan, called a draft Remedial Action Plan (RAP) was developed specifically for the approximately 270 acre site located northeast of the 405 Freeway located primarily at 340 East 192nd Street in Carson, including the Victoria Golf Course, the Victoria Cricket Fields, a portion of the Victoria Regional Park, the Goodyear Airship Center, and the MB Landscape Nursery. In compliance with the California Environmental Quality Act (CEQA), DTSC prepared a Notice of Exemption (NOE), as the proposed RAP activities will not have a significant effect on human health and the environment.

DTSC is the lead regulatory agency for review and approval of the RAP. The draft RAP, if approved, will address potential exposure threats from buried wastes at this former landfill. Although groundwater impacts are present at the site, they are being monitored by DTSC. A separate RAP for groundwater will be developed and implemented in the future.

There is **no** current health risk from landfill gasses at the Site, as indicated by ongoing monitoring. Also, groundwater under the Site is **not** a source of drinking water. DTSC has determined there are chemicals present at the Site that are above protective standards and DTSC requires a cleanup plan be developed and implemented to ensure long-term public health and safety. Why Remedial Action Is Necessary

The Victoria Golf Course Site (former BKK Carson Landfill) is part of the former BKK Carson Landfill. The landfill served principally as a municipal waste landfill, and as part of landfill operations, waste that contained total petroleum hydrocarbons (TPHs), volatile organic compounds (VOCs), semi-volatile organic compounds (SVOCs), polycyclic aromatic hydrocarbons (PAHs), and/or metals was placed in excavated trenches that were then covered with soil. Typical of landfills that contain organic materials, the landfill waste is currently undergoing natural decay, which generates landfill gases including methane. Quarterly landfill gas monitoring has been ongoing at the former landfill since the 1980s. There is no current risk to health because the public is not exposed directly to contaminated onsite soil or landfill gas. However, because of potential degrading or thinning of the landfill cover, or digging activities through the landfill cover (by site workers) that could lead to potential exposure to increased landfill gas emissions or direct exposure to contaminated soil, DTSC recommends a RAP be implemented to protect the public, site workers and the environment. DTSC will oversee the cleanup activities and ensure work is performed in a manner protective of human health and the environment.

Site Location & History

The approximately 270 acre Site was part of the approximately 372 acre former BKK Carson Landfill. The Site has multiple owners including Los Angeles County, Goodyear Tire and Rubber, Watson Land Company, and the City of Carson. The Site is located northeast of the 405 Freeway along the Dominguez Channel and Del Amo Boulevard on the south-southwest, roughly along 192nd Street on the north, Avalon Boulevard on the east, and Main Street on the west, in a mixed residential and commercial area. Currently, the Site is developed as the Victoria Golf Course, Victoria Cricket Fields, a portion of Victoria Regional Park, Goodyear Airship Operations Center, MB Landscape Nursery, Dominguez Channel and Branch Channel, and City of Carson public street rights-of-way.

The former BKK Carson Landfill operated from about 1948 to 1960 and the Site is part of that former landfill. It stopped accepting waste in December 1959, and thereafter subsequently closed. Following closure, the landfill was subdivided into different parcels. The parcels northeast of and including the Dominguez Channel is the subject of this draft RAP. *Parcels southwest*

of the Dominguez Channel, including the Dominguez Golf Course Site are currently being addressed in a separate RAP.

Site Investigations Conducted

Numerous limited environmental investigations have been conducted over the years that indicate the presence of contamination is caused from past landfill activities. The most recent investigation for soil, soil gas (and groundwater), was completed to: 1) identify areas of impacts, and 2) identify viable cleanup options.

The environmental investigation known as a Remedial Investigation/Feasibility Study (RI/FS) included the collection and analysis of samples from soil cover, waste zone soil, soil gas, and native soil. The investigation included:

- 75 Soil gas/landfill gas wells/probes
- 123 direct-push soil sample borings
- 111 hand-dug borings
- 22 groundwater monitoring wells

The Site soil and soil gas were found to be contaminated at levels requiring action with chemicals including petroleum hydrocarbons, VOCs, heavy metals, pesticides, and polychlorinated biphenyls (PCBs). The investigation also included soil gas sampling in the yards of five homes located along the northern boundary of the Site. Sampling results at these homes indicated no exposure threat to the residents.

Groundwater Update

DTSC determined additional environmental investigation and groundwater data from the entire former landfill, including the Dominguez Golf Course portion is appropriate. Therefore, the investigation report and draft RAP for this Site involves soil and soil gas media only.

Proposed Remediation Plan – draft RAP

The goal of the RAP is to make sure the buried waste present at the Site is sufficiently contained and that the landfill cover is protective of human health and the environment. To address residual contamination present in soil and soil gas, the draft RAP proposes:

- 1) Monitoring and Maintenance of the Site Cap – Ongoing Site monitoring and inspection of existing soil cover would continue. Appropriate maintenance would be conducted, as needed, the requirements for which will be documented in an Operation, Monitoring and Maintenance Plan for each Site property.

2) Landfill Gas Monitoring – Regular landfill gas monitoring for the Site perimeter, on-site and at the surface, regular soil cover inspections and appropriate maintenance work be conducted as needed. Methane alarms will be installed in all enclosed-space slab-on-grade buildings. Also, health and safety monitoring will be required for site workers during any intrusive or land-disturbing activities. Protective actions will be taken if any monitoring indicates landfill gas is present at levels that could pose potential risks.

3) Institutional Controls – Institutional control documents (deed restrictions) will be implemented to prevent sensitive land uses (such as constructing hospitals or schools), and to prohibit disturbance of the Site soil unless approved by the landowner and DTSC. Also, three (3) soil areas will be documented as “areas of concern” (location-specific institutional control), requiring notice to Site workers if any digging were to occur causing any exposure risk.

4) Paving One Soil Area – One soil area of concern (about 25 square yards) will be surface paved. About one (1) truckload of concrete is anticipated to be transported to the Site for the paving activity.

The entire Site will be subject to regular inspection and monitoring to ensure the Site continues to be protective for the public’s use and for on-site workers.

California Environmental Quality Act (CEQA)

DTSC is required by CEQA to review environmental activities for the possibility of impacts, before approving the project. DTSC prepared a Notice of Exemption (NOE) for this project, as the proposed RAP activities will not have an adverse environmental impact.
