Delru/Rigid Flex, Incorporated 875 South East Street Anaheim, CA 92805

The Department of Toxic Substances Control (DTSC) invites the public to review and comment on a proposed cleanup plan for the former Delru/Rigid Flex Inc. site located in Anaheim, CA. The proposed cleanup plan, called the Corrective Measure Implementation (CMI) workplan, describes the site environmental sampling activities, the results, and the cleanup activities proposed for the Site.

DTSC is the state agency that regulates the generation, storage, treatment and disposal of hazardous waste in California, and will oversee the cleanup at the facility is completed according to state standards.

SITE HISTORY: The former Delru/Rigid Flex, Incorporated (Delru) is composed of approximately 10,880 square feet and is located in a commercial/industrial area.

- Delru/RigidFlex has operated at the site since at least 1974.
- Plating and circuit board manufacturing did not begin at the site until approximately 1984.
- On December 16, 1999, a fire within the onsite plating area destroyed the westernmost part of the facility. The fire resulted in the spill of potentially hazardous plating solutions onto the floor of the plating room, as well as the adjoining southern open area.
- An investigation conducted in June 2000 by Foss Environmental and EPI revealed that the soil underlying the plating room had minor impacts from bases, acids, and metals.
- Soil vapor studies were conducted within and adjacent to the project area in 2003 and January 2014.

- The most recent sampling event from January 2014 shows that the PCE concentrations in soil vapor beneath the site exceeded the California Human Health Screening Levels.

WHY CLEANUP IS NECESSARY?

Soil vapor studies were completed in 2003 and 2014. The results of the studies show that residual volatile organic compounds, primarily tetrachloroethene (PCE) remain beneath and adjacent to the project area. **The residual PCE concentrations do not pose a significant threat to human health.** The proposed cleanup is intended to reduce PCE's potential impact workers at the site.

PROPOSED CLEANUP ACTIVITIES:

The proposed cleanup will be comprised of two parts:

- 1) backfilling of the excavation with clean soil and
- 2) Installation of a passive venting system.

SAFETY MEASURES DURING CLEANUP

There will be a site specific health and safety plan in place during the implementation of fieldwork that will comply with applicable parts of the Occupational Safety and Health Administration (OSHA) Regulations.

CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

DTSC has determined that the proposed project activities will have no significant impact on the environment. DTSC has prepared a CEQA Notice of Exemption (NOE) for this project.

HOW YOU CAN PARTICIPATE:

DTSC welcomes your input during the public comment period. At the close of the public comment period, and before making a final decision on the Corrective Measure Implementation (CMI) workplan DTSC will review and respond in writing to all public comments. A Response to Comments document will be sent to all persons who submit comments.
