A draft Post-Closure Permit for Ducommun AeroStructures, El Mirage Facility is available for public review and comment. If approved, this post-closure permit would allow the facility to continue maintenance and environmental monitoring of the closed, regulated hazardous waste unit at the site.

PUBLIC COMMENT PERIOD AND MEETING

The public comment period for the draft Permit, and draft CEQA Notice of Exemption begins on September 9 and ends October 26, 2009. Why a Permit is Necessary

The Department of Toxic Substances Control (DTSC) is a department within the California Environmental Protection Agency. DTSC regulates the generation, storage, treatment, and disposal of hazardous waste in California. A permit enables DTSC to effectively regulate the hazardous waste management activities at facilities. DTSC is authorized to impose special conditions in this Permit pursuant to Health and Safety Code section 25200(a) and the regulations in California Code of Regulations, title 22, division 4.5, governing tanks, containers, and other facility and operation standards. Permits are developed after DTSC's technical review, and are intended to ensure that the facility operates in a manner that protects human health and the environment.

Facility Description and History

The Ducommun AeroStructures El Mirage Facility is located at 4001 El Mirage Road, within the community of El Mirage, an unincorporated area of San Bernardino County.

Ducommun and previous facilities at the site, performs chemical milling of aerospace components. This operation uses corrosive solutions of acids and bases to chemically etch various metal components to specifications. A resulting corrosive wastewater is produced containing dissolved metals.

From 1967 to 1978, Andalite Inc. operated at this location. Andalite discharged their corrosive wastewaters into a 2.25 acre, unlined percolation pond. Use of the pond was discontinued in 1978 when Andalite was bought by Aerochem Inc.

Aerochem constructed a 0.75 acre lined surface impoundment within the pond. The surface impoundment was used to store and treat some of Aerochem's wastewaters before sending it off-site for further treatment and/or disposal. Aerochem stopped using the surface impoundment in October 1987.

Aerochem closed the pond and surface impoundment together, as a combined regulated unit. The closed regulated unit occupies 3.1 acres within Ducommun's 20 acre property. The wastewater remaining in the impoundment was removed and sent off-site.

The remaining sludge and sediment was stabilized, solidified and returned back into the impoundment. A multi-layered landfill cap was installed over the former surface impoundment and the former pond, to cover the stabilized waste. Aerochem submitted a Closure Certification to DTSC in November 1991. DTSC issued a post-closure permit to Aerochem in November 1995.

In January 2001, Aerochem Inc. and other entities were combined to form Ducommun AeroStructures, the current operator at this location.

This regulated unit is currently closed and does not accept any additional waste. **Ducommun does not operate any active permitted hazardous waste management unit(s) at the El Mirage Facility.**

Draft Post-Closure Permit

The proposed post-closure permit authorizes continued groundwater monitoring during the corrective action activities. The permit also regulates maintenance activities to ensure the integrity of the installed landfill cap.

California Environmental Quality Act

Under the California Environmental Quality Act, DTSC must evaluate whether the proposed actions may have any significant impacts on human health and the environment. As part of this evaluation, DTSC has prepared a draft Notice of Exemption which states that issuance of the post-closure permit renewal will not have a significant negative effect on human health or the environment.

Corrective Action History

Ducommun has ongoing compliance obligations related to groundwater and soil contamination resulting from the etching operations. Cleanup remedies are being evaluated under the oversight of DTSC. In addition, Ducommun is required to prepare and submit an Interim Measures Work Plan (IMWP) to address groundwater contamination at the site. The IMWP proposes to conduct groundwater extraction activities to achieve the following:

- Control the movement of contamination in the groundwater
- Reduce the source of contamination through soil vapor extraction
- Expand the groundwater monitoring system and provide drinking water to nearby residents

How You Can Participate

Before making a final determination on the draft Permit, DTSC will review and respond in writing to all public comments. A Response to Comments document will be sent to all those who submitted public comments and to those who request a copy. The draft Post-Closure Permit and other site-related documents are available for public review at the information repositories listed below. The administrative record for Ducommun is available in the DTSC Cypress Field Office. Documents include copies of the permit application, the draft CEQA Notice of Exemption, this fact sheet and other site-specific documentation.
