# Exide: Schedule of Meetings

The Department of Toxic Substances Control (DTSC) invites public comment on the Exide Draft Remedial Action (Cleanup) Plan and Draft Environmental Impact Report (DEIR).

The public comment period ends on **February 15, 2017**.

DTSC will hold three public meetings on the Draft Cleanup Plan and DEIR where a court reporter will be present to record any oral comments provided during the meeting. Reasonable limits will be set for time allowed for oral comments. A written transcript of the oral comments provided during each meeting will be made available to the public.
