RE: IMPLEMENTATION OF SENATE BILL (SB) 1249 (Hill, Chapter 756, Statutes of 2014)

Dear Mr. Adams:

The purpose of this letter is to inform you that your metal shredding facility at 901 New Dock Street, Terminal Island, California 90731 and its activities are subject to evaluation by the Department of Toxic Substances Control (DTSC) under recently enacted SB 1249.

On January 1, 2015, SB 1249 became law, which requires DTSC to evaluate thoroughly metal shredding facilities and the metal shredder waste they generate to ensure these activities do not harm public health and the environment. Based on the findings from the evaluation, DTSC will determine if management requirements can be developed specifically for metal shredding activities and wastes as an alternative to full hazardous waste management requirements while still remaining protective of human health and the environment.

DTSC is developing a draft Work Plan that will detail the specific activities DTSC intends to carry out as part of its evaluation of metal shredding facilities and to prepare the comprehensive analysis required by SB 1249. When ready, DTSC will post its draft Work Plan on its web page and will welcome your feedback on the plan.

DTSC acknowledges that some of the information it anticipates needing to conduct its evaluation will become available with the implementation of the treatability study work plan developed and submitted by the metal shredding industry in 2013. However, DTSC may be more actively involved in the implementation of the study to ensure the findings can be used to evaluate the risks and hazards posed by wastes treated using the treatment methods identified in the study.


DTSC thanks you for your cooperation thus far related to the treatability study. In addition to the treatability study, SB 1249 requires DTSC to evaluate other activities at metal shredding facilities. To carry out the other elements of the evaluation and analysis required by SB 1249, DTSC will be seeking additional information from you regarding the metal shredding activities that occur at your facility. Your cooperation in responding to these requests will assist DTSC in its efforts and allow DTSC to meet the deadlines established in SB 1249. Very soon, DTSC will send a detailed request for information, and asks that you provide the requested information as quickly as possible.
