15-DAY PUBLIC NOTICE AND COMMENT PERIOD NOTICE OF PUBLIC AVAILABILITY OF DOCUMENTS

DISASTER VICTIMS HAZARDOUS WASTE FEE EXEMPTION

Pursuant to Government Code section 11346.8, subdivision (c), notice is hereby given that the Department of Toxic Substances Control (DTSC) has revised the text and the Initial Statement of Reasons of the proposed regulations which would adopt Section 66269.2 into the California Code of Regulations, Title 22, Division 4.5, Chapter 19. A written comment period has been established commencing on *July 16, 2012*, and closing on July 31, 2012.

DTSC mailed the original text and made it available for public review and comment on *April 13, 2012*. Written comments were accepted during the 45-day public comment period that ended May 29, 2012. DTSC has now made post-hearing changes to the proposed text and Initial Statement of Reasons. It considers these new changes to the rulemaking to be sufficiently related changes, as defined by California Code of Regulations, title 1, section 42.

A copy of the revised text is attached. The bold/double-strike through and the bold/double-underline text represents the most current revisions to the text. The information upon which DTSC relied is available for public inspection between 8:00 a.m. and 5:00 p.m. at the Regulations Section, located on the 22nd Floor at 1001 I Street, Sacramento, California.
