EMERGENCY PERMIT UNIVERSITY OF CALIFORNIA LOS ANGELES 550 CHARLES YOUNG DRIVE, WEST LOS ANGELES, CALIFORNIA

On July 23, 2018, University of California Los Angeles requested an Emergency Permit from the California Department of Toxic Substances Control (DTSC) for onsite treatment of expired chemicals at 550 Charles Young Drive, West, in Los Angeles, California 90095. The items to be treated include twelve chemicals in twenty-one containers. These chemicals are Tetrahydrofuran (1x250ml), Diethyl Ether (1x20ml), Sodium Amide (1x100grams), 2,4 Dinitrophenol (1x5grams), Diphenylphosphoryl Azide (1x25grams), Borane T H F Complex (4x100ml), Potassium (2x500g, 3x50g, 1x20g), Benzoyl Peroxide (1x25g, 1x1.2g), Diethyl Azodicarboxylate (1x25grams), Picrylsulfonic Acid (1x100 grams), 1-Hydroxy-7-azabenzotriazole (1x50grams) and Picric Acid (1x250ml).

Clean Harbors Environmental Services has been contracted to conduct this treatment. The chemicals are potentially reactive and unsafe for transport in their present state. The treatment involves the addition of liquid solution to the containers to stabilize the chemicals. Once the chemicals are treated, they will be transported offsite for proper management. DTSC has determined that the chemicals pose an imminent and substantial endangerment to human health and the environment if not properly managed. Therefore, an emergency permit should be issued. This Emergency Permit is effective from

August 7, 2018 - October 5, 2018. The Emergency Permit includes measures to minimize any adverse impact to the community and the environment.

CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA): DTSC has determined that the project is exempt from the requirements of CEQA and has filed University of California Los Angeles' request for this project are available for review at the a Notice of Exemption (NOE) with the State Clearinghouse.
