## DRAFT REMOVAL ACTION WORKPLAN

## FORMER ALLEN CLEANERS Chino, California 91710

30-Day Public Comment Period: May 29 through June 29, 2020

WHAT IS BEING PROPOSED: The Department of Toxic Substances Control invites you to comment on a draft Removal Action Workplan (RAW) to be completed at the Former Allen Cleaners (Site) locations in the Country Fair Shopping Center (CFSC) in Chino, California. The Site consists of two suites within the 19-acre CFSC, Suite 12051 and Suite 12075 (now Café Donuts), both formerly occupied by Allen Cleaners. The owner of the property, PK I Country Fair SC LP, is working cooperatively with DTSC to clean up the Site from historical releases of dry-cleaning solvent, tetrachloroethene (PCE) and its breakdown products, to the environment.

The Draft RAW proposes the following: (1) excavation of about 600 cubic yards of soil from the Site containing the highest concentrations of PCE; 2) disposal of the excavated soils at an offsite State-certified recycling or disposal facility; 3) installation of a soil vapor extraction (SVE) system to remove residual PCE in soil; 4) backfilling the excavation with clean material, 5) monitoring of the SVE system to ensure proper cleanup, and 5) recording of a land use covenant (LUC) on the Site to restrict future Site uses to commercial. The LUC will prohibit future Site uses for any of the following purposes: a residence, hospital, school, or daycare center without prior written approval by DTSC. This institutional control requires continued evaluation and monitoring of the Site to ensure conditions are protective of human health and the environment.
