Enforcement - DTSC's Enforcement Division monitors the operation of permitted hazardous waste facilities and transporters, and investigates complaints filed with CalEPA. DTSC enforcement activities include site inspections, enforcement follow-up, evaluating compliance histories of permitted facilities, reviewing proposed facility permits, and investigating complaints. DTSC's Enforcement costs are primarily funded from the Hazardous Waste Control Account (HWCA).



Site Mitigation and Restoration Program (Cleanup Program) - oversees the evaluation and cleanup of contaminated properties, including military facilities, school construction and expansion projects, tiered permitted facilities, brownfields, and voluntary agreements. DTSC also performs investigations and cleanup at orphan sites (sites with no viable responsible party). DTSC's Cleanup Program costs are primarily funded from the Toxic Substances Control Account (TSCA).



Permitting: DTSC's Permitting Division evaluates applications for hazardous waste facility permits and renewals. DTSC's permitting activities include time taken reviewing permit applications, developing appropriate permit conditions, evaluating financial assurances, and reviewing closure plans and cost estimates. DTSC's Permitting costs are primarily funded from the Hazardous Waste Control Account (HWCA).
