RESPONSE TO SHIPMENT PLAN FOR REVERB FURNACE FEED ROOM LETTER  
DATED FEBRUARY 23, 2015, EXIDE TECHNOLOGIES, VERNON, CALIFORNIA;  
EPA ID. NO. CAD097854541

Dear Mr. Strang:

The Department of Toxic Substances Control (DTSC) has reviewed the letter dated February 23, 2015, from Advanced GeoServices regarding the Shipment Plan for the Reverb Furnace Feed Room. The letter describes a plan by Exide Technologies (Exide) to ship feed material currently located within the Reverb Furnace Feed Room Containment Building offsite (Plan). The letter states that the Plan will be implemented following approval by DTSC.

DTSC hereby approves Exide's Plan to ship the reverb furnace feed material offsite with the following conditions:

- (1) Exide shall remove all reverb furnace feed material from the Containment Building and transport it offsite by May 1, 2015.
- (2) DTSC is also approving an extension of the one year storage limit for reverb furnace feed material currently stored in the Containment Building in accordance with the terms of Exide's Interim Status Document (ISD). (ISD, paragraph II.1.(a), page 3.) This extension shall be through May 1, 2015.
- (3) Exide shall pay in April 2015 the activity fee for land disposal for all waste remaining in the Containment Building after March 11, 2015.
- (4) Exide shall not place additional feed material or wastes on the temporary liner system in the Containment Building.
- (5) Exide shall provide DTSC weekly with a daily log of shipments of reverb feed material identifying the number of trucks and total weight of material shipped for each day.

- (6) All shipments must use registered hazardous waste transporters, hazardous waste manifests and be delivered to an authorized hazardous waste facility.
- (7) All shipments must be transported in accordance with all federal, state and local laws and regulations.
- (8) The letter dated February 23, 2015, from Advanced GeoServices must be signed and certified in accordance with the requirements in California Code of Regulations, title 22, sections 66270.11(b) and (d). Please submit a signed cover letter by March 2, 2015, referencing the February 23 letter from the appropriate officer or representative which meets these requirements.
