Glossary

Completed	Cleanup activities completed - lead contaminated soil has been removed and yard has been restored.
In Progress	Cleanup activities are in progress - lead contaminated soil is currently being excavated or removed from the property.
Scheduled	Pre-construction activities have been completed and the property has been scheduled for cleanup.
Declined Cleanup	Property Owner(s) has declined cleanup - lead contaminated soil removal and restoration has been declined.
In Communication	DTSC representatives are in communication with the property owner to begin the cleanup process.
Initial Meeting	Initial meeting with the property owner and DTSC representative to describe what activities will take place during soil lead cleanup.
Outreach In Progress	DTSC representatives are in the process of contacting the property owner to engage them in conversation on the soil lead cleanup.
Pre Construction	Pre-Construction meeting is held by representatives from DTSC and the Contractor with each property owner and resident, to describe the cleanup activities to be performed at the property.
