## End of Five-Year Review California Steel Industries Inc.

The Department of Toxic Substances Control (DTSC) has completed the Five-Year Review for the cleanup remedy at California Steel Industries Inc. (Site). The Site is located at 14000 San Bernardino Avenue, Fontana, California 92335.

The Site consists of approximately 422 acres of land located in the southwestern portion of San Bernardino County, east of the city of Rancho Cucamonga and west of the city of Fontana. A large portion of the Site is used for processing finished steel products and a smaller portion is used as a commercial business park. Site investigations identified two areas of concern (AOC) at the Site with elevated levels of polyaromatic hydrocarbons, metals, and volatile organic compounds in the soil. In 2015, DTSC approved a Remedial Action Plan and Closure Plan for the Site. The remedy included asphalt paving and land use restrictions to limit exposure and prevent surface water from infiltrating soil. An Operation, Maintenance, and Monitoring Plan was approved in 2016 to provide guidelines for maintaining and inspecting the paved surfaces. An additional AOC discussed in the Five-Year Review document is being managed by the United States Environmental Protection Agency due to elevated polychlorinated biphenyls and is not subject to DTSC oversight.

The purpose of a Five-Year Review is to ensure the chosen environmental remedy is still effective, functioning as designed, and is maintained appropriately to protect human health and the environment. Annual inspections and Five-Year Reviews are conducted at the Site to ensure that the remedy continues to function as designed. Based on DTSC's review of the Five-Year Review document, the remedy is still effective in protecting human health and the environment. The next Five-Year Review will be conducted in 2026.
