RENEWAL OF A HAZARDOUS WASTE FACILITY POST CLOSURE PERMIT FORMER INTERNATIONAL LIGHT METALS FACILITY 19200 SOUTH WESTERN AVENUE TORRANCE, CALIFORNIA 90501

WHAT IS BEING PROPOSED?

On October 7, 2022, the California Department of Toxic Substances Control (DTSC) received the Post Closure Permit Renewal Application (Permit Application) for the Former International Light Metals Facility (Facility). This Facility is located at 19200 South Western Ave., Torrance, California, 90501. The Former International Light Metals Facility requests authorization from DTSC to continue post closure activities including groundwater monitoring in four Hazardous Waste Management Units (HWMUs). After DTSC completes its review of the Permit Application, DTSC will then prepare a draft Permit for public review and public comment.

The site comprises approximately 67.4 acres in a fully developed area zoned for general commercial and industrial use. The developed property is rectangular in shape and is fully developed and contains 5 warehouse/distribution office buildings.

Maintenance and groundwater monitoring are required for the four HWMUs under the current Permit. If DTSC renews the Permit, the Former International Light Metals Facility will continue the post closure monitoring activities. These activities include groundwater monitoring, site inspections and maintenance of all associated structures and equipment.
