## EMERGENCY PERMIT THERAVANCE BIOPHARMA 901 GATEWAY BOULEVARD SOUTH SAN FRANCISCO, CALIFORNIA 94080

The California Department of Toxic Substances Control (DTSC) has issued an Emergency Permit to Theravance Biopharma for onsite treatment of expired chemicals 901 Gateway Boulevard. The item to be treated include twenty-four (24) containers of Methyl Isobutyl Keytone, Cyclopentyl Methyl Ether, 2-Methyltetrahydrofuran, Acetaldehyde, Tetrahydrofuran, Acrylonitrile, Ethyl Acrylate, Methacrylic Acid, Acrylic Acid, t-Butyl Acrylate, 2,2 Azobisisobutyronitrile, Boran THF, Sodium Amide, 2,4 Dinitrophenylhydrazine, 5-Amino-1H Tetrazole, and Tetra-n-Butylammonium Azide.

The Clean Harbors Environmental Services (Clean Harbors) has been contracted to conduct these treatments. The chemicals are potentially reactive and unsafe for transport in their present state. The treatments involve the addition of solutions to the containers to stabilize the chemicals. Once the chemicals are treated, it will be transported offsite for proper management. DTSC has determined that the chemicals pose an imminent and substantial endangerment to human health and the environment if not properly managed. Therefore, an emergency permit should be issued. This Emergency Permit is effective from November 16, 2022 through January 16, 2023. The Emergency Permit includes measures to minimize any adverse impact to the community and the environment.

**CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA):** DTSC has determined that the issuance of this permit is exempt from the requirements of CEQA and has filed a Notice of Exemption (NOE) with the State Clearinghouse.
