What was covered in last week's ECRGenius #1?

Site Eligibility

- 1. Brownfield
- 2. Own or have access
- 3. Census tract where CES 4.0 Score is 75% or greater

If the CES 4.0 Score is less than 75%:

CES Poverty Percentile must be 50% or greater

OR

Reuse must be for 100% affordable housing and supportive services

Tribal uses are eligible regardless of the CES 4.0 Score Applicant Eligibility

- 1. Public entity
- 2. Nonprofit with 501(c)(3) status
- 3. Tribe, regardless of federal recognition
- 4. ECRGrantees who have expensed at least 70% of their current grant allocation

What is the "Site"?

- Applicant defines "Site"
 - Entire site must meet all eligibility criteria
 - Can be the eligible portion(s) of a broader development
 - No more than two owners
 - No more than one CERCLA liability defense

• Site name on the application should match what is on the Regulatory Oversight Agreement

Should you apply for investigation or cleanup?

- Site-specific Cleanup applications must have a cleanup plan submitted to or approved by their environmental regulatory agency
- If a cleanup plan has not been submitted, apply for a **Site-specific Investigation**
- If unsure talk to your regulatory oversight agency
- Regulatory Oversight Agency will confirm in the <u>Project</u> <u>Suitability Letter</u> if Applicant is ready to prepare or implement a cleanup plan



What are the access and ownership requirements?

Guidelines Section 2.2:

• Access: Applicant must own the site or document access for two-year funding period

This applies to all parcels at a Site

Examples:

- Applicant provides grant deed naming Applicant as the owner for each parcel
- Applicant provides Purchase and Sale Agreement
- Applicant provides written Access Agreement

If there are more than two owners, separate ECRG applications need to be submitted

Equitable Community Revitalization Grant

What is a CERCLA liability defense?

Guidelines Section 2.5:

"To be eligible for a **Site-specific Investigation** or **Site-specific Cleanup**, applicants must demonstrate that they are not in any way liable for any releases or threatened releases of hazardous substances at the site(s) under the Comprehensive Environmental Response, Compensation, and Liability Act of 1980 (CERCLA or federal Superfund law).

The demonstration that a party is not responsible for the contamination as defined under CERCLA is referred to as establishing a "CERCLA liability defense".

For **Site-specific Cleanup**, applicants must demonstrate that either they, or the owners, have a CERCLA liability defense."

When is CERCLA liability defense required?

Guidelines Table 1 & ECRG Self-Check Tool

¹ Tribes are exempt from the requirement to demonstrate a CERCLA Liability Defense for sites they own.

Is CERCLA liability defense required for all grants?

- Community-wide Assessment No
- Site-specific Investigations:
 - Yes for Applicants who own the site
 - No for Applicants who do not own the site, but must provide an Owner Attestation Form
- Site-specific Cleanups: Yes for the owner, whether it is an Applicant or not

Municipalities/Local Governments may have exemptions depending on how the site was acquired (i.e. involuntary acquisitions) - consult your legal counsel Tribes that own sites never need a CERLCA Liability Defense

If a CERCLA Liability Defense is required, it must be provided for <u>each parcel</u>

Who can provide environmental regulatory oversight?

- Required for Site-specific Investigations and Site-specific Cleanups
- Optional for Community-Wide Assessments
- Can be provided by:
 - DTSC
 - Regional Board
 - Local Oversight Agency
 - Tribe*
- If it is not DTSC, a <u>Project Suitability Letter</u> is required

DEADLINES FOR REQUESTING NEW OVERSIGHT AGREEMENTS

- DTSC September 11, 2023 (Submit a Request for Agency Oversight application via Fluxx)
- Regional Board September 11, 2023
- Local Agency Contact them directly, recommend no later than September 5, 2023

*Tribes conducting environmental oversight should meet with DTSC

What else do you need to know about regulatory oversight?

- Agreement must be voluntary; cannot be an order
 - DTSC, Standard Voluntary Agreement
 - Local Agency, Voluntary Remedial Action Agreement
 - Regional Board Cost Recovery Letter
 - Regional Board Section 13267 Order if approved by the Regional Board via <u>Project Suitability Letter</u>
- Regulatory oversight agreement must be in the applicant's name
- A copy of the voluntary agreement and <u>Project Suitability Letter</u> are required

What is the Project Suitability Letter?

Dear Ms. Tasnif-Abbasi:

We EnCouRaGe environmental investigation and cleanup. We EnCouRaGe you to apply.

What costs are eligible under ECRG and how do I budget them?

- ECRG requires that prevailing wage rates be used where applicable and used when estimating the budget for ECRG Tasks
- Have contracting practices to ensure fair market costs through a competitive procurement process for contracts over \$10,000
- Have a contracting policy that requires diverse suppliers be considered, such as disabled veteran business enterprises, disadvantaged business enterprises, or small business enterprises
 - <u>Quick Reference Guide</u> on how small businesses can become certified and participate in upcoming contract opportunities

Equitable Community Revitalization Grant

We EnCouRaGe environmental investigation and cleanup. We EnCouRaGe you to apply.

What are ineligible costs?

- Eligible tasks were shown on slide 16
- Only cover tasks related to environmental assessment, investigation and cleanup
 - Engagement activities related to ECRG Tasks
 - Section 2.8 lists ineligible tasks
- If ineligible tasks are included, the grant application can be denied

If unsure ask us first

What are the requirements for reuse?

- Reuse must benefit disadvantaged or vulnerable communities
 - If the reuse is housing, school, hospital, or day care, will the cleanup approach evaluated be one that does note require land use controls?
 - Reuses that have the potential to cause significant pollution are disallowed

- Community-wide Assessment select a minimum of one
- Site-specific Investigation select a minimum of two
- Site-specific Cleanup under \$5 million select a minimum of two
- Site-specific Cleanup \$5 million or more select a minimum of three
