

1. ECRG's MISSION & VISION

The ECRG is a historic investment in California's vulnerable and disadvantaged communities to address historic environmental injustices and set a path to improve public health and revitalize brownfields.

ECRG's mission is to EnCouRaGe beneficial reuse of land through assessment, investigation, and cleanup and to advance environmental justice goals through concerted support and deep investment in vulnerable and underserved communities

2. ELIGIBILITY

Public entities, nonprofits, and tribes are eligible to apply to conduct environmental assessment, investigation and cleanup in California's most disadvantaged areas. Equitable Community Revitalization Grant

What was covered in ECRGenius #1, #2 and #3?

ECRGenius#1: Overview & Eligibility

Applicants must be:

✓ Public entity

✓ Nonprofit with 501(c)(3) status

- \checkmark Tribe, regardless of federal recognition
- ✓ ECRGrantees who have expensed at least 70% of their current grant allocation

Sites must be:

✓ In census tract of CES 4.0 Score of 75% or greater

For CES 4.0 Scores less than 75%:

CES Poverty Percentile 50% or greater

OR

100% affordable housing

Tribal uses are eligible regardless of the CES 4.0 Score

Application pre-submittal review

Working with CCLR dramatically increases ECRG success 95% of applicants who worked with CCLR got funding in Round 1
