**WHAT IS BEING PROPOSED?** The Department of Toxic Substances Control (DTSC) invites you to comment on the Draft Hazardous Waste Facility Permit Renewal (Draft Permit Renewal) for the Chemical Waste Management Inc. Kettleman Hills Facility (Facility). If approved, a Final Permit would be issued for up to a 10-year period, with continued authorization if the Facility meets submittal requirements. The Permit would allow the Facility to transfer, treat, store, and dispose of hazardous waste. The Facility has been in operation since 1979.

DTSC encourages you to comment on the Kettleman City Vulnerability Evaluation using CalEnviroScreen Data and the Draft Permit Renewal. Before making a final decision, DTSC will consider and respond to all public comments. A Response to Comments document will be sent to everyone who submitted a comment or requests a copy.
