## EMERGENCY PERMIT TO MANAGE HAZARDOUS WASTE THERMO FISHER SCIENTIFIC

**6055 SUNOL BOULEVARD, PLEASANTON, CALIFORNIA 95466**

The California Department of Toxic Substances Control (DTSC) has issued an Emergency Permit to Thermo Fisher Scientific for onsite treatment of expired chemicals at 6055 Sunol Boulevard Pleasanton, California, 95466. The items treated include (5) 4-liter containers of tetrahydrofuran (THF), (3) 500-milliliter containers of ethyl ether, (1) 4-liter container of THF/acetic anhydride and (1) 600-gram container of 1-hydroxybenzotriazole.

Clean Harbors Environmental Services (Clean Harbors) has been contracted to conduct the treatment at Thermo Fisher Scientific. The chemicals are potentially reactive and unsafe for transport in their present state. The treatment involves the addition of solutions to the containers to stabilize the chemicals. Once the chemicals are treated, they will be transported offsite for proper management. DTSC has determined that these chemicals pose an imminent and substantial endangerment to human health and the environment if not properly managed. Therefore, an Emergency Permit should be issued. This Emergency Permit is **effective from July 23, 2024 through October 21, 2024**. The Emergency Permit includes measures to minimize any adverse impact to the community and the environment.

**CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA):** DTSC has determined that the issuance of this permit is exempt from the requirements of CEQA and has filed a Notice of Exemption (NOE) with the State Clearinghouse. ## 15-year-old girl is killed, man wounded in Sunday shooting

**HAYWARD** » A 15-year-old girl died and a 41-year-old man was injured in a shooting Sunday morning, according to Hayward police.

Police did not immediately release the girl's name. They said she was a Hayward resident but did not specify if she lived in the area of the shooting.

Police said the man wounded was a Hayward resident. Investigators do not believe that the girl and man knew each other.

Gunfire was reported around 11:15 a.m. Sunday outside in the 900 block of West Tennyson Road, Officer Cassandra Fovel said.

Responding officers found the girl suffering from fatal injuries. She died later at a hospital.

The man was found a short distance away, in the 28000 block of Ruus Road. He was taken to a hospital for treatment of non-life-threatening injuries, police said.

A motive for the shooting has not been released. But police said two separate groups of people, some apparently in at least one car and others on the street, had an exchange

of gunfire.

The girl killed was standing near the group on the street, but whether she was an intended target has not been determined yet, police said. The man shot was apparently just walking in the area, police said.

Fovel said no arrests had been made but police have recovered a vehicle believed used in the shooting as well as a firearm also believed to have been used in the shooting. Police did not say where the vehicle and gun were found but did say that they were found separately.

The killing is the eighth homicide investigated by Hayward police this year and the fourth consecutive one where the victim was 18 or younger.

An 18-year-old man was fatally shot July 13 near the

intersection of Pompano Avenue and Sumatra Street.

An 18-year-old Pleasanton man died July 3 from gunshot wounds suffered June 27 while he was driving in the area of Mission Boulevard and Industrial Parkway. A 17-year-old boy, also a Pleasanton resident, who was a friend of the 18-year-old, was wounded.

On June 26 a 15-year-old Rodeo boy was killed in a shooting in the 24000 block of 2nd Street that left a 13-year-old Hayward boy wounded.

Police have not announced any arrests in the earlier cases and Fovel said there is nothing to indicate any of the four incidents are related. Anyone with information about Sunday's killing is asked to call Detective Navas at 510-293-7176.

the two victims for several hours before the man was taken back to Fremont and released somewhere in the Fremont hills, police said. The woman, police said, was left at the Manteca home and told she was "now going to be their slave."

The man reported injuries to the back of his head and

bruising all over his body. The woman reported a bleeding injury to her ear and soreness to her back.

She "did not provide many details of what occurred at the residence but said she was not hit. She appeared nervous and scared. She was visibly shaking" when interviewed by police, authorities said.

The brother-in-law denied he ever hit the victims while at his Manteca home and made "veiled threats, only to scare them," according to

court records.

The two men were booked into Santa Rita Jail following their arrest by surveillance teams in Manteca and San Ramon, with the Fremont man's bail set at \$655,000 and the Manteca man's at \$210,000. They are no longer in custody, according to the county's online jail logs.

The men both pleaded not guilty at an arraignment hearing on July 22 and are next scheduled to appear in court on Sept. 11.
