## EMERGENCY PERMIT MICROVENTION TERUMO 35 ENTERPRISE ALISO VIEJO, CALIFORNIA 92656

The California Department of Toxic Substances Control (DTSC) has issued an Emergency Permit to MicroVention Terumo for onsite treatment of expired chemicals at 35 Enterprise. The items to be treated include: one (1) container of 2-ethylhexyl acrylate, fifty (50) containers of 2-hydroxyethyl methacrylate, one (1) container of 2-methoxyethyl acrylate, fourteen (14) containers of acryloyl chloride, three (3) containers of carboxyethyl acrylate, one (1) container of ethylene glycol dimethacrylate, one (1) container of glycerol monomethacrylate, one (1) container of glycidyl methacrylate, one (1) container of iso-decyl acrylate, ten (10) containers of methacryloyl chloride, one (1) container of n-octyl methacrylate, twelve (12) containers of 2,2 azobis (2-2 methylpropionitrile) and six (6) containers of 4,4 azobis (4-cyanovaleric acid).

The Clean Harbors Environmental Services (Clean Harbors) has been contracted to conduct the treatment. The chemicals are potentially reactive and unsafe for transport in their present state. The treatment involves the addition of solutions to the containers to stabilize the chemicals. Once the chemicals are treated, they will be transported offsite for proper management. DTSC has determined that these chemicals pose an imminent and substantial endangerment to human health and the environment if not properly managed. Therefore, an Emergency Permit should be issued. This Emergency Permit is effective from June 22, 2023, through August 19, 2023. The Emergency Permit includes measures to minimize any adverse impact to the community and the environment.

**CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA):** DTSC has determined that the issuance of this permit is exempt from the requirements of CEQA and has filed a Notice of Exemption (NOE) with the State Clearinghouse.
